NOTICE INVITING TENDER

For Procurement, Milling, Packaging, Handling and Distribution of Spices for Supply to Kerala State Civil Supplies Corporation.

The Kerala State Cooperative Marketing Federation Ltd. (MARKETFED) invites technical and financial proposals from eligible firms/agencies having proven experience in procurement, milling, packaging, handling and distribution of spices for supply to the Kerala State Civil Supplies Corporation.

The selected agency shall be responsible for procurement of raw spices, processing, quality assurance, packaging as per approved specifications, and transportation/distribution to designated Civil Supplies depots across Kerala.

Scope of Work

The successful bidder shall undertake the following activities:

- Procurement of quality raw spices.
- Cleaning, grading and milling of spices in hygienic and FSSAI-compliant facilities.
- Handling, loading and unloading of finished products.
- Transportation and distribution to designated Civil Supplies Corporation depots across Kerala.
- Compliance with all quality specifications prescribed by MARKETFED and Civil Supplies Corporation.
- Submission of batch-wise quality reports and delivery documents.

Spices Covered

The tender covers procurement and processing of the following spices:

- Black Mustard
- Fenugreek
- Cumin Seed
- Fennel Seed

Eligibility Criteria

Interested bidders shall submit the following details along with supporting documents:

Technical Information

The bidder shall provide:

- Processing capacity (MT per month)
- Packaging facilities available
- Storage capacity

Financial Proposal

The financial bid shall separately indicate:

- Procurement charges
- Milling charges
- Packaging charges
- Handling charges
- Transportation and distribution charges
- Applicable GST
- Any other incidental charges

Rates shall remain firm during the contract period unless otherwise approved by MARKETFED.

Payment Terms

The bidder shall clearly specify:

- Credit period offered
- Documents required for raising invoices
- Bank account details

Payment shall generally be released by MARKETFED after receipt and acceptance of materials by the Kerala State Civil Supplies Corporation, submission of invoices and supporting delivery documents, and verification of quality and quantity.

Inspection

MARKETFED reserves the right to:

- Inspect the manufacturing and milling facilities before finalisation of the tender.
- Conduct surprise inspections during the contract period.
- Verify production capacity, quality control systems and statutory compliance.
- Reject bids if the infrastructure is found inadequate.

Quality Requirements

The bidder shall ensure:

- Procurement of good quality raw spices conforming to prescribed standards.
- Hygienic processing under FSSAI norms.
- Uniform milling and packing.
- Moisture and quality parameters as prescribed by MARKETFED/Civil Supplies Corporation.
- Batch-wise traceability and quality documentation.

General Conditions

- MARKETFED reserves the right to accept or reject any or all tenders without assigning any reason.
- Submission of the tender does not confer any right for award of work.
- The successful bidder shall execute an agreement with MARKETFED before commencement of work.
- All disputes shall be subject to the jurisdiction of courts at Ernakulam.
